Full Golf Membership

As a full voting member and shareholder, with your Golf Membership you will enjoy all of Honesdale Golf Club amenities including unlimited championship golf without green fees on our private course, practice facilities, clubhouse, dining and a full year-round social calendar with events and activities for the entire family as well as business associates and friends. Membership includes voting rights and stock options. These members own a share of stock and are eligible to vote and hold office on the board of directors. Stock is \$500 and can be paid over two years as \$125 semiannual payments. The annual membership is \$1300 which includes a \$50 scrip at the bar and restaurant.

Junior Membership (Age 14 - 15 Yrs.)

Junior Full Golf Members enjoy all of the same member benefits as Full Golf Members. There is no initiation fee, scrip, or bond. \$385 Yearly Dues.

Junior Membership (Age 16 - 20 Yrs.)

Junior Full Golf Members enjoy all of the same member benefits as Full Golf Members. There is no initiation fee, scrip, or bond. \$575 Yearly Dues. Junior Members must be at least 16 years of age and have a valid automobile driver's license to operate a golf cart.

Social Membership (Class 1)

As a social member there is no initiation fee or bond. Annual dues cost \$575 with \$50 scrip, and \$100 Assessment. Social Membership (Class 1) is open to any individual over the age of 36. Membership includes limited golf with green fees.

Young Adult Membership Full Golf (Age 21 - 35) *

Associate Young Adult Full Golf Members enjoy all of the same member benefits as Full Golf Membership, excluding voting rights. The annual dues cost \$575 with \$150 scrip to the bar and restaurant. Young Adult Members are eligible for full use of the course, club house, and tournaments. Membership includes unlimited golf with no green fees. Young Adult Members are encouraged to bring guests as green fee players. Nonrefundable \$125 yearly payments toward your bond will begin at the age of 32 of the member.

Family Member *

A non-equity family member is open to all new members over the age of 21 who is the spouse or life partner of a voting member. Annual dues cost \$575 with \$150 scrip. Non-Equity Family Members are eligible for full use of the course, club house, and tournaments. Membership includes unlimited golf with no green fees. Non-Equity Family Members are encouraged to bring guests as green fee players.

Second Club Membership *

A non-equity second club member is open to all members. There is no initiation fee or bond. Annual dues cost \$575 with \$150 scrip. This membership is open to members of another golf club. Full use of the grounds, club house, invitation to all tournaments, unlimited golf, no green fees, and bring guests as green fee players.

Part Time Golfing Social Membership *

A non-equity social member is open to all individuals over the age of 21. There is no initiation fee or bond. Annual dues cost \$200 with \$150 annual scrip. Part Time Golfing Social Memberships may enjoy the same amenities as members in our bar and restaurant with play at the posted green fee rates.

Prospective Member (1 Year) (Non-Equity) *

A non-equity prospective member is open to all new members for period of one year only. There is no initiation fee or bond. Annual dues cost \$385 with \$150 scrip. Full use of the grounds, club house, invitation to all tournaments, unlimited golf, no green fees, and bring guests as green fee players.

Non-Golfing Social Member*

A non-equity non-golfing social member is open to all new members over the age of 21. There is no initiation fee or bond. Annual dues cost \$100 with \$300 scrip to be used in the restaurant and bar only. Full use of the club house excluding golf privileges.

Corporate Membership

The Corporate Membership was designed to welcome corporations to our club at a great price for membership. The annual cost will be negotiated per designated member includes unlimited golf with a cart and a \$50 paid scrip with an additional \$100 free scrip for the bar and restaurant. Open to all corporations. For corporations designating from 1 to unlimited memberships the following is included in the fee per member. 1. Four guest passes for a free round of golf. (Cart fees not included.) 2. All designated officers of the corporation are allowed full use of the bar, restaurant, and dining room of the club for personal and or corporate entertainment. The officers must be designated by name and voted on by the board to purchase alcohol at the bar. 3. Each corporation designating four or more memberships receive 5 guest passes for a free round of golf. (Cart fees not included.)
